The current 2007 standards (page 15) includes a section following the preface entitled "Purpose of Chiropractic Education" which provides a definition of the chiropractic profession that reflects the laws of the majority of the states and the consensus statements of the Association of Chiropractic Colleges (ACC Paradigm) that is universally accepted throughout the profession. It should not be deleted from the standards.

The current "proposed" standards has deleted a section that exists in the current 2007 standards that addresses the commonly accepted definitions of the chiropractic profession. These statements are and should continue to be the foundation of chiropractic education.

II. Purpose of Chiropractic Education

The purpose of chiropractic professional education is to provide the student with a core of knowledge in the basic and clinical sciences and related health subjects sufficient to perform the professional obligations of a doctor of chiropractic. ...

The application of science in chiropractic concerns itself with the relationship between structure, primarily the spine, and function, primarily coordinated by the nervous system of the human body, as that relationship may affect the restoration and preservation of health.

Further, this application of science in chiropractic focuses on the inherent ability of the body to heal without the use of drugs or surgery.
